### BECOMING AN APPOINTEE

Unfortunately, there may come a time when an elderly or infirm friend or relative becomes increasingly dependent on those around them and is unable to look after their own affairs.



Many people are aware of the option of applying for full power of attorney through the courts, but not perhaps aware of the possibility of becoming an appointee to deal with social security matters through the DWP.

An appointee can be a friend, relative, lawyer, or a representative of an organisation, such as a social worker. It is not a role to take on lightly, as an appointee becomes fully responsible for acting on the customer's behalf when dealing with DWP. An appointee must also ensure that the customer's benefit payments are used for the dependent person's interest. However, it is an option worth bearing in mind, especially since taking action now to ensure a dependent friend or relative's affairs are in order could avoid problems in the long run.

### HEALTHCARE: REGISTERING AS A DEPENDANT ON A SPANISH WORKER OR BENEFIT HOLDER

As many of you may know, Spanish healthcare is a contributions-based system. If you are not paying into the system yourself, nor are you entitled to healthcare from the UK (see <http://ukinspain.fco.gov.uk> for more details), but someone in your household is paying into the



Spanish system, you can apply to be registered as that person's dependant for healthcare purposes through the INSS (Spanish social security)

Previously an applicant for dependency only had to produce evidence of living at the same address and marriage/birth certificates. The INSS have now stated, however, that all dependants must also provide a certificate that shows they are not entitled to healthcare from their country of origin. For the UK, this means you will need to request a 'legislation letter', in Spanish, from the Overseas Healthcare Team on 0044 191 218 1999.

## The British Consular Network, Spain

**In the first of a two part property special, we would like to draw your attention to some useful advice on buying property in Spain.**

**Do your homework:** It is important to thoroughly research the area you are considering purchasing in, as well as companies you might use (developers, estate agents and lawyers). It is also worth looking at online forums covering Spanish property such as the [Spanish Property Insight](#) and [Eye on Spain](#) forums to learn from others' experiences and ask questions about the local area, the purchase process, developers, lawyers and agents.

**Seek independent legal advice:** Appoint a lawyer who is experienced in property law and fully independent of anyone else involved in the transaction e.g. the estate agent, vendor and developer. Do not sign any papers or hand over any money until you have sought independent legal advice.

**Look at the "UK in Spain" website** which has a list of precautions to take before you buy, documentation you should have in hand before you complete and advice on dealing with property issues should they arise. If you are already a property owner and are experiencing problems, there is also a range of advice available on the property issues section of our website.

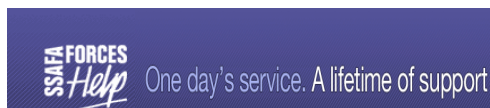


From supporting serving personnel and their families to ex-personnel, ACASA can provide experienced and friendly advice as well as a variety of practical services.

## Working in Partnership

Last month, the British Consulate in Alicante, the Diputación of Alicante and the Alicante Central Social Welfare Department carried out two workshops to help support vulnerable British residents in the Alicante province. The workshops formed part of an ongoing project called **ConeXiones**, which aims to connect different groups and promote joint working and communication to better support vulnerable residents in Alicante.

In total, there were just under a hundred people who attended both events. As well as Age Concern and The RBL, social services from 25 town halls also attended, along with representatives from English-speaking associations such as Asociación Española Contra el Cáncer, Alzheimer's Association, Help at Home, Costa Blanca Samaritans, MABS and various branches of HELP. Feedback was overwhelmingly positive, with 85% of attendees saying the workshops would be very useful for their future work.
